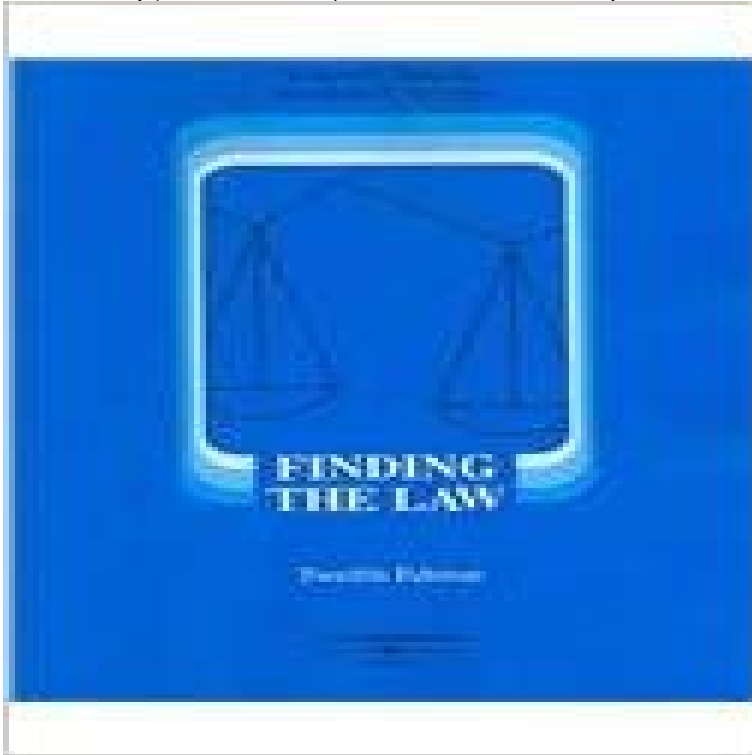


## Finding the Law, 12th Edition (American Casebooks)
