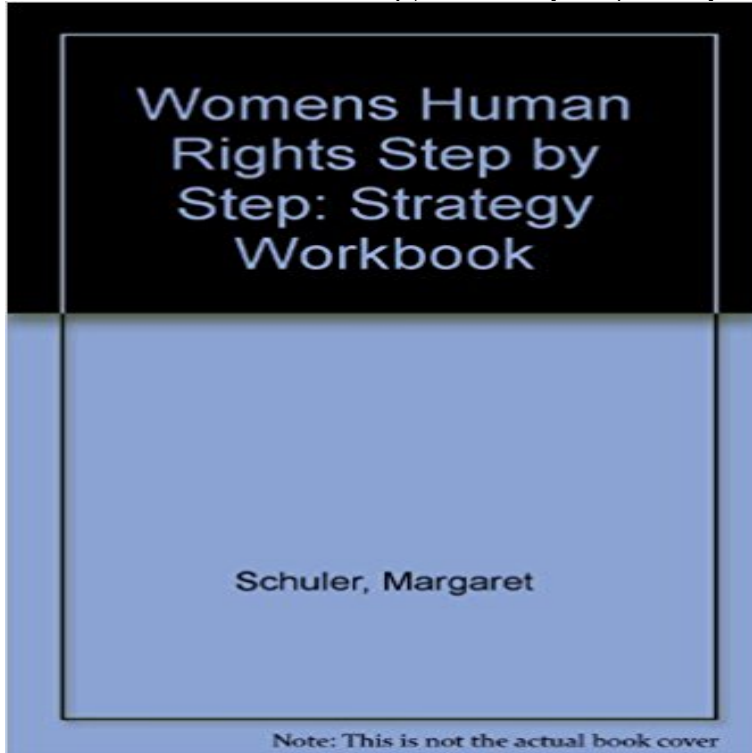


# Womens Human Rights Step by Step: Strategy Workbook
