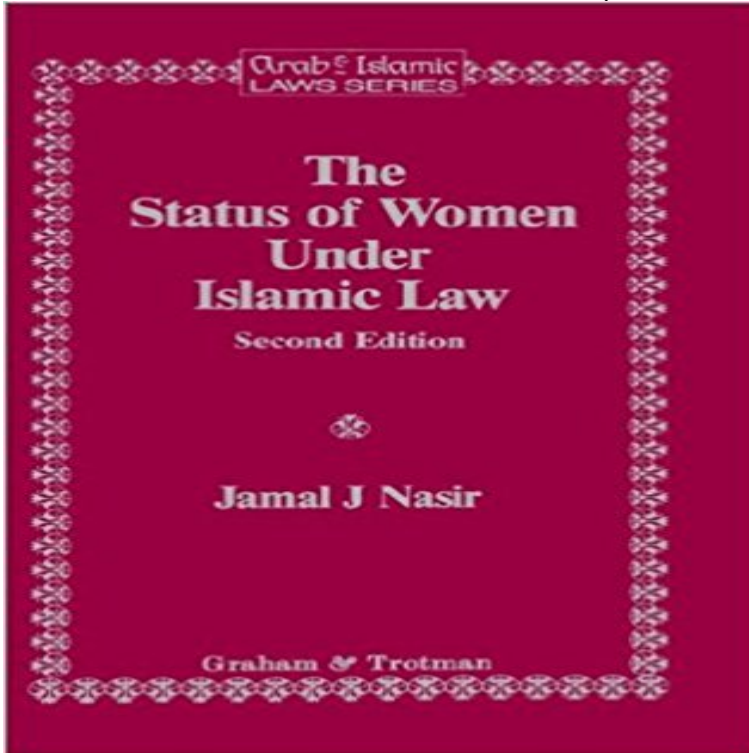


Status of Women under Islam (Arab & Islamic Laws)
