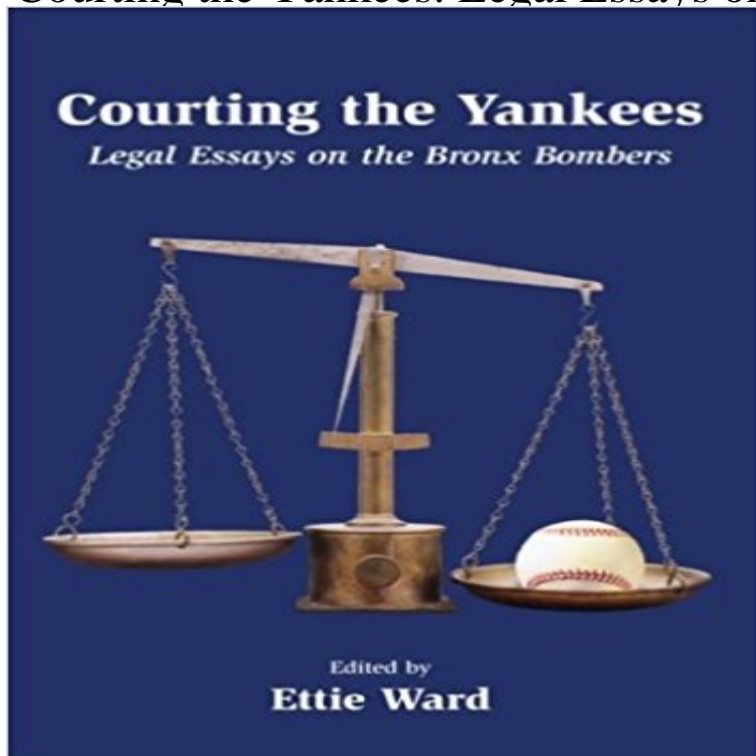


## Courting the Yankees: Legal Essays on the Bronx Bombers
