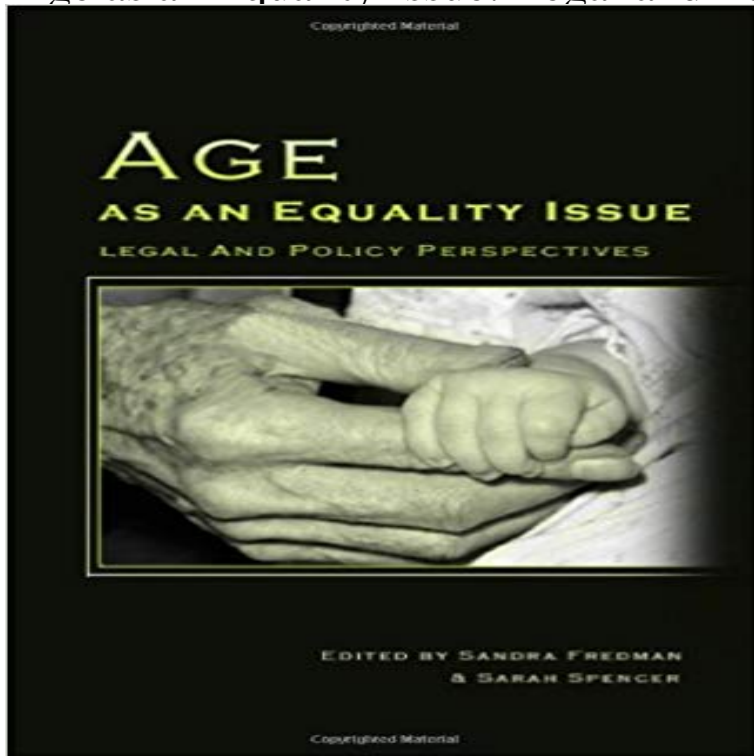


Age as an Equality Issue: Legal and Policy Perspectives
