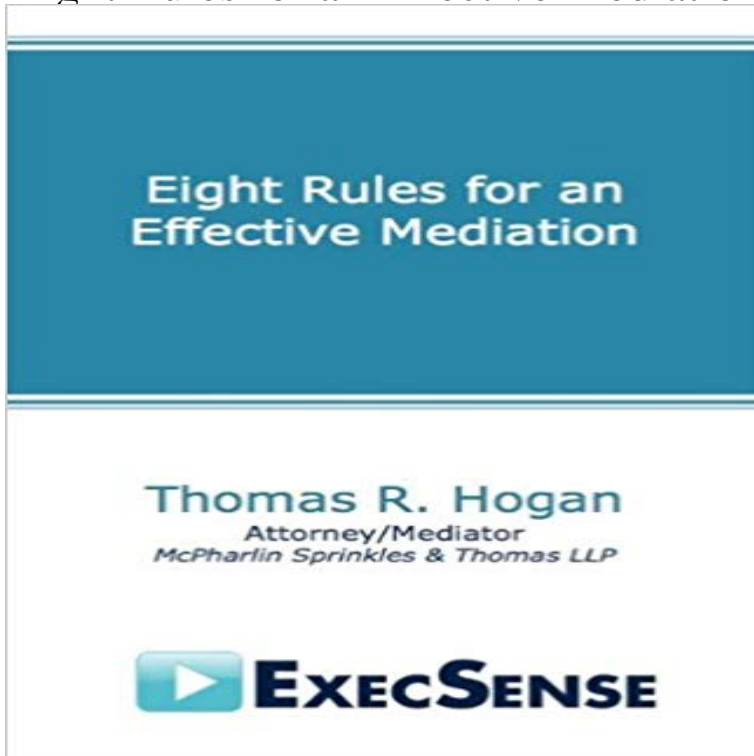


## Eight Rules for an Effective Mediation

In mediation a peaceful settlement between disputants is the definition of success. While preparation will not guarantee success, the parties themselves make the final decisions, and careful preparation by the mediator will increase the likelihood of success. This preparation will set the stage and provide the foundation upon which the parties can come to a reasonable resolution. Some believe that a long history of wise judicial decisions while suitably robed or consistent courtroom success over an extended period suffices. Certainly, most of the esteemed mediators in our legal community have these or similar backgrounds. My own experience and careful observance of the procedures followed by these mediators reveals that their preparation goes well beyond what may be found in their curriculum vitae. Each of the following cases illustrates one or more preparation requirements that should be on every mediators checklist.
