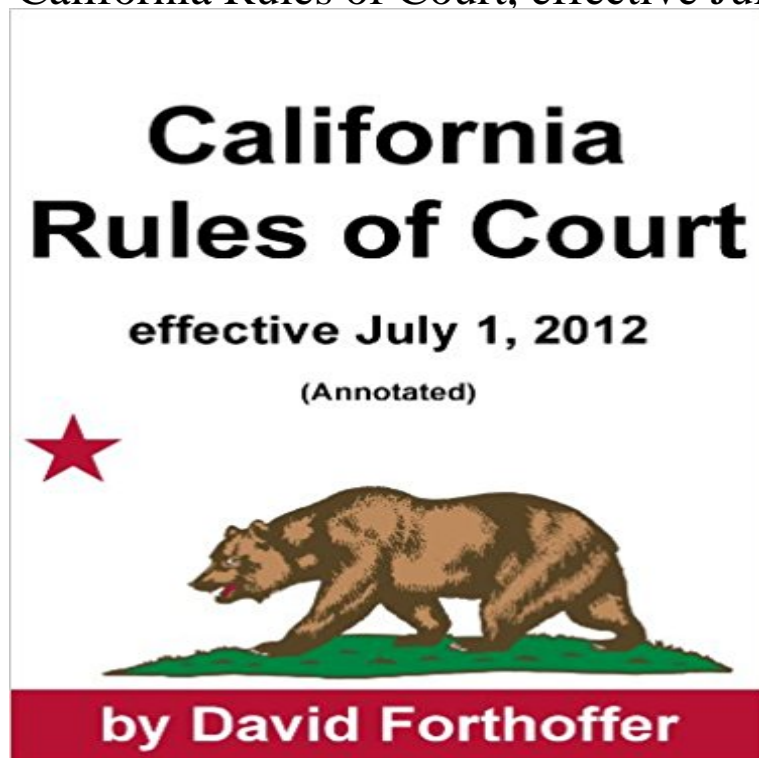


California Rules of Court, effective July 1, 2012 (Annotated)



This is the first truly effective eBook rendition of the California Rules of Court, effective July 1, 2012. Although you can freely get the official version (in the form of 17 PDF files or one ZIP file) from the California state web site, the official version is practically useless on a Kindle, iPad, etc., because it is extremely cumbersome to navigate. Here are some of the features of this eBook. (a) The Table of Contents, all ten Titles, all four Appendixes, the Ethics chapter, and the Standards chapter are all combined into a single eBook. (b) You can easily browse by title, part, division, chapter, etc., with link text large enough to click on what you want. (c) If you know the rule number, form label, etc., you can quickly find those. (d) If a rule references a form or another rule, you can usually click on the linked text to get to the referenced form or rule. More than 10,000 such links have been incorporated into this eBook. (e) Forms link to the official California Forms repository, so you can quickly bring up forms. This is especially useful from your PC. (f) More than 100 errors in the Rules have been found and documented, ranging from minor to egregious. (g) The forms referenced in Appendix A have been correlated with the official list of forms, and many forms listed in the latter have been added to this eBook. Browse this eBook now to see if it will make life easier for you or your staff!

Second Edition: The following changes have been made to the second edition, released July 19, 2012. (1) Missing revision histories have been added titles, divisions, chapters, etc.. (2) Addendum E (Glossary, Cases, Notes, and Errata) has been split into five addendums, as follows. E. Errata F. Codes G. Glossary H. Cases I. Notes (3) New Addendum F (Codes) now includes the index pages from all California Codes with live links to the on-line code sections. However, the Financial Code was inadvertently omitted.

Rather than delay publication another day, and because the Rules do not reference the Financial Code, decision was made to defer its inclusion.⁴) References to rules, codes, forms, etc. outside of Advisory Committee Comments have been linked to the associated entries.⁵) Other minor errors have been corrected.⁶) Updated Appendix A (Forms) and Appendix E (Errata) according to the new official Judicial Council Forms, having a revision date of July 1, 2012, and released some time after July 4, 2012. This included listing revision histories in Appendix A for new or revised forms (i.e. retaining the former revision date).
