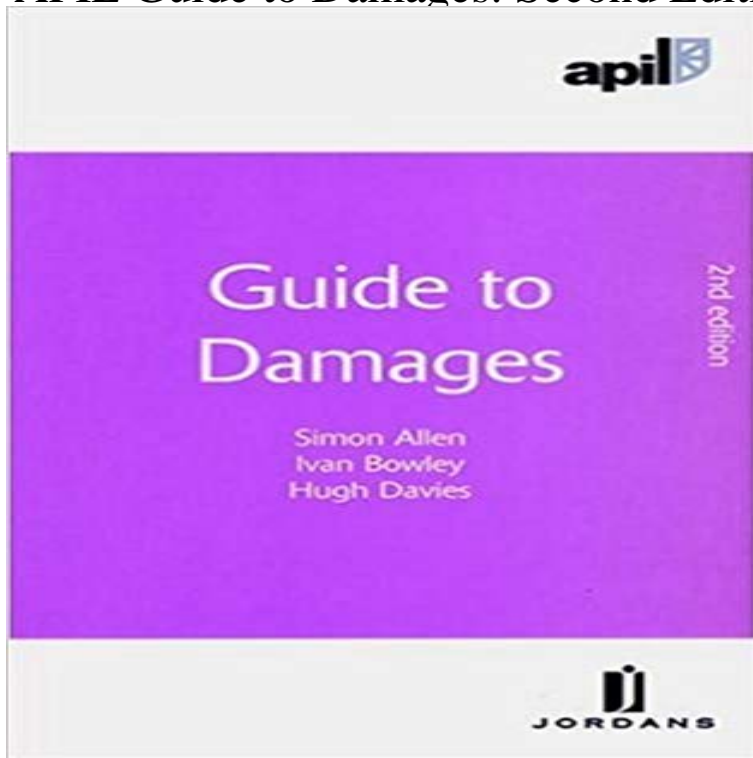


## APIL Guide to Damages: Second Edition
