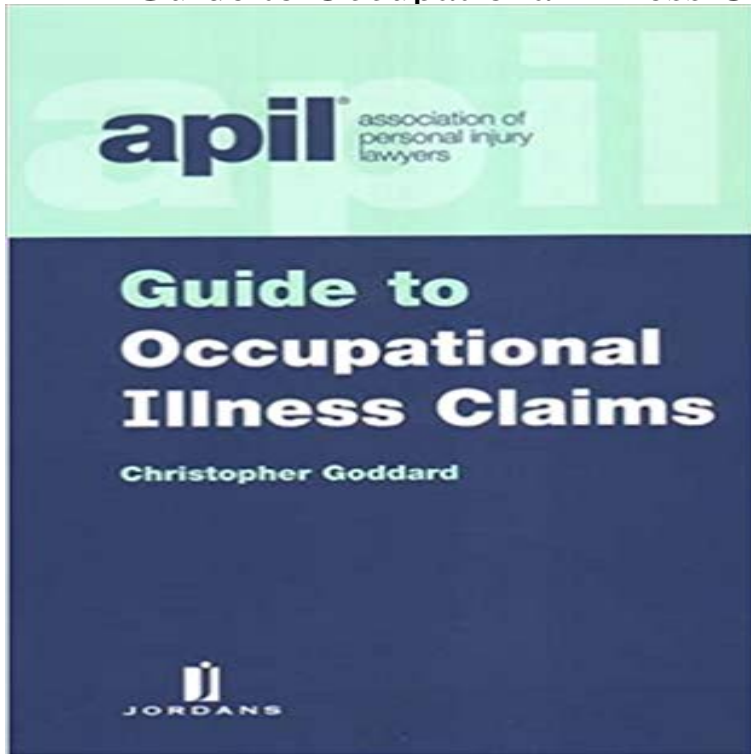


## APIL Guide to Occupational Illness Claims
