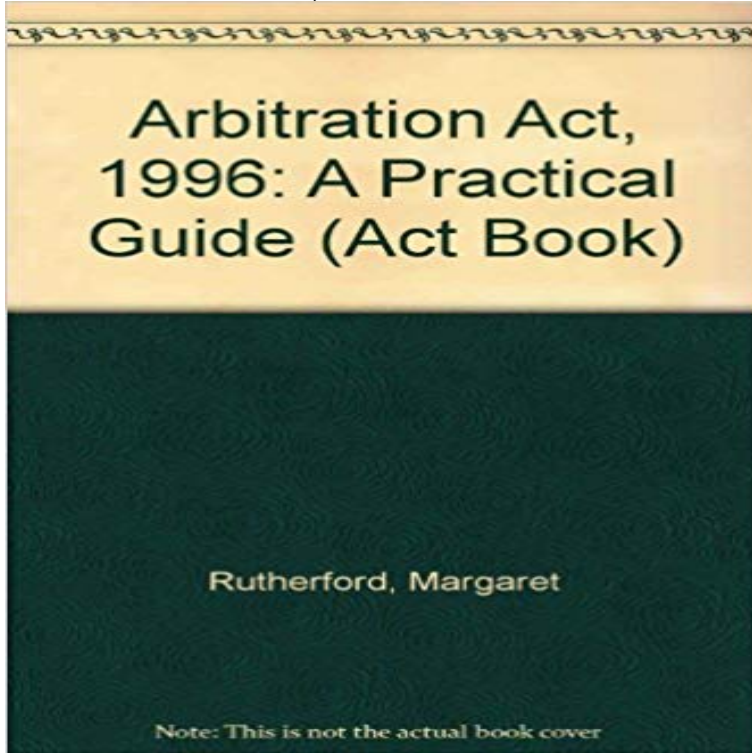


Arbitration Act, 1996: A Practical Guide (Act Book)
