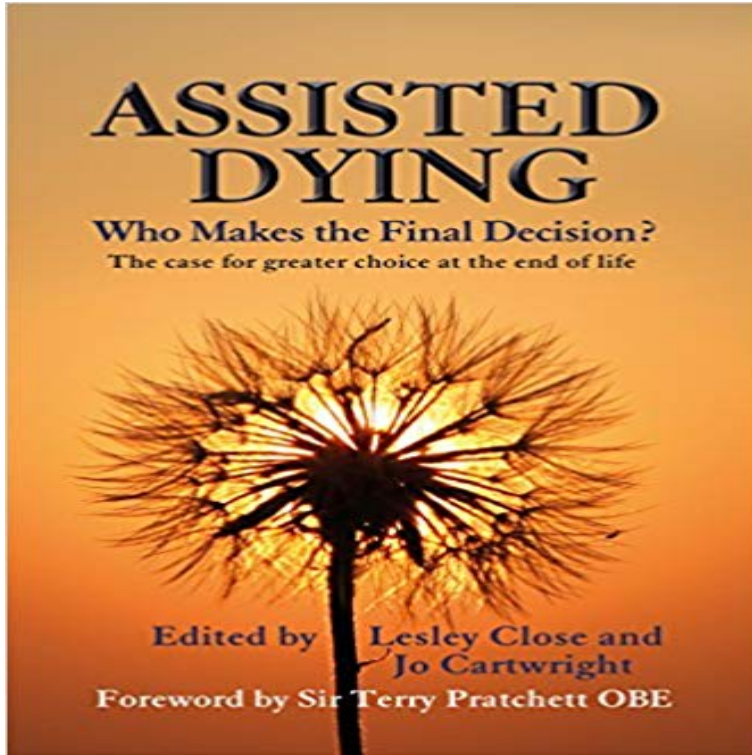


Assisted Dying: Who Makes the Final Decision?: The case for greater choice at the end of life
