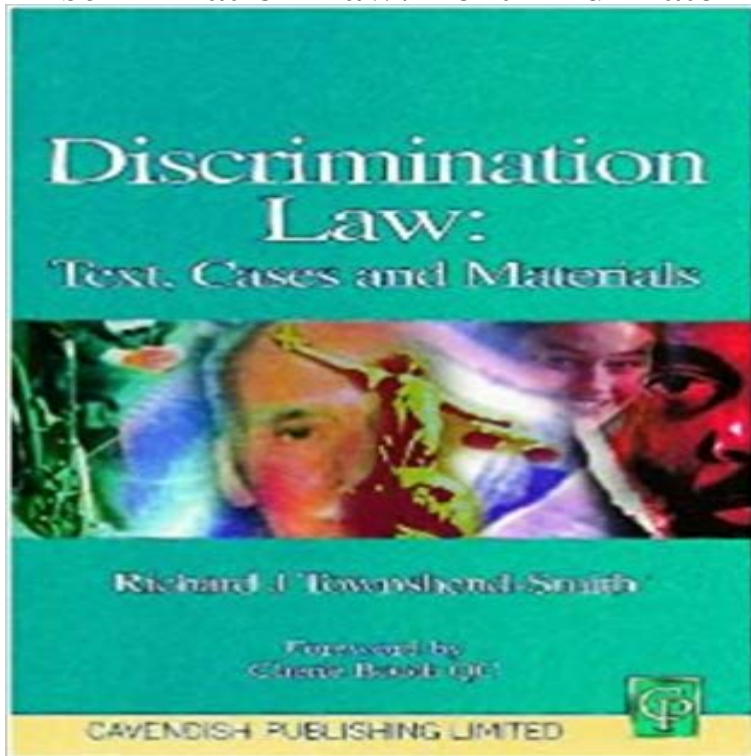


Discrimination Law: Text And Materials
