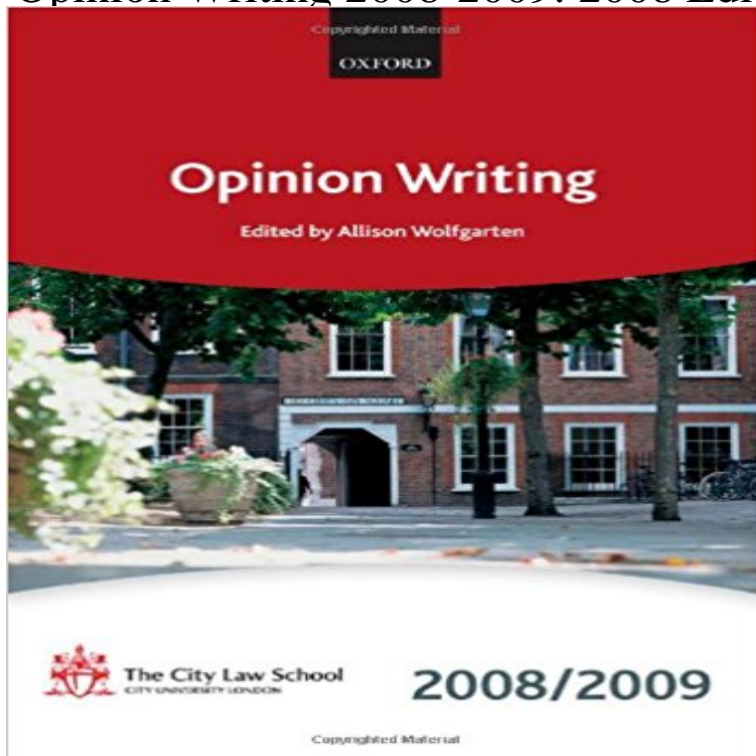


## Opinion Writing 2008-2009: 2008 Edition (Blackstone Bar Manual)
