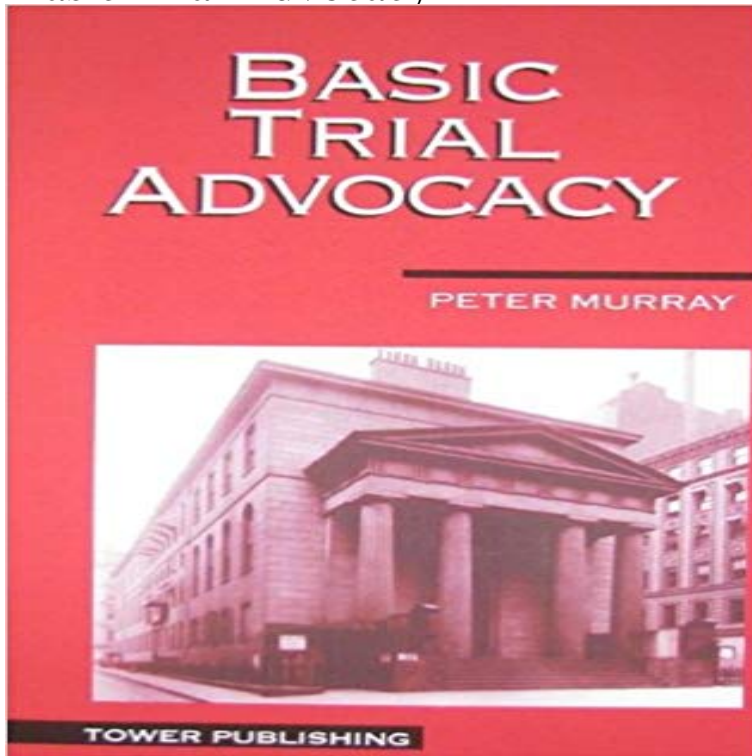


## Basic Trial Advocacy
