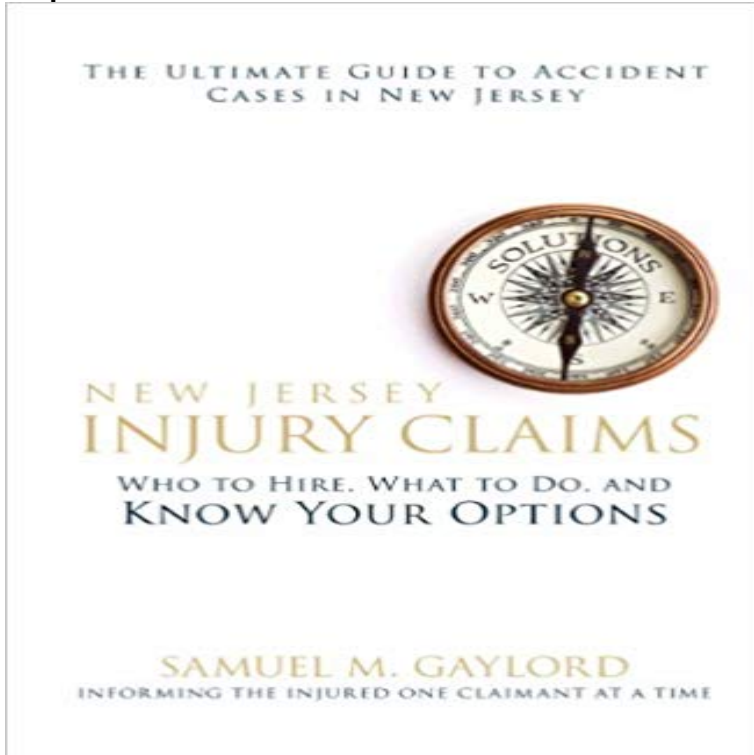


# New Jersey Injury Claims: Who to Hire, What to Do, and Know Your Options
