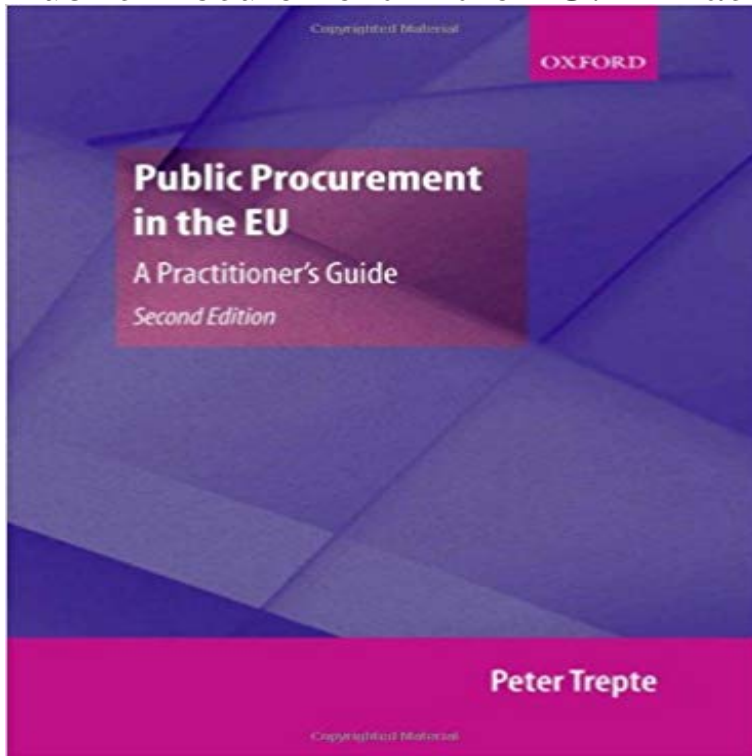


# Public Procurement in the EU: A Practitioners Guide
