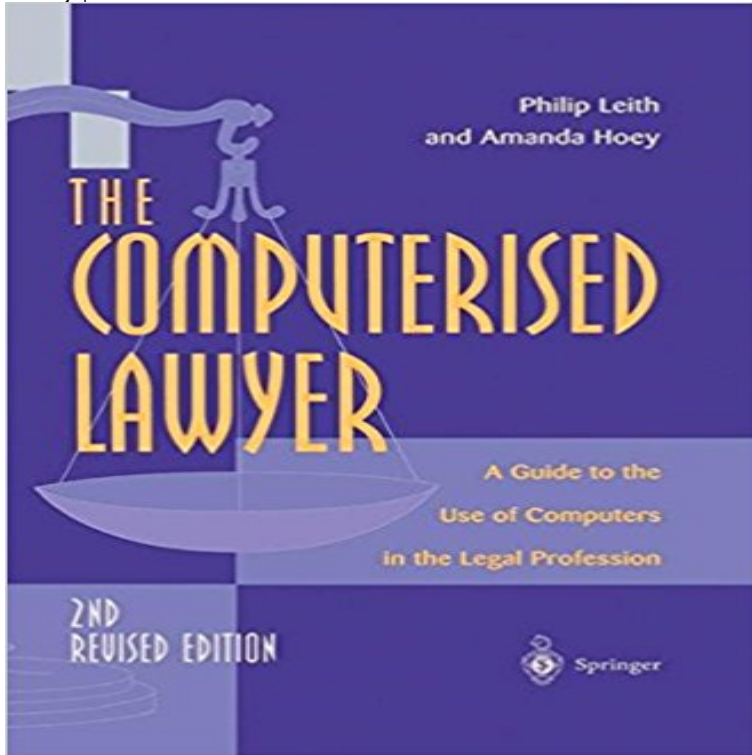


The Computerised Lawyer: A Guide to the Use of Computers in the Legal Profession
