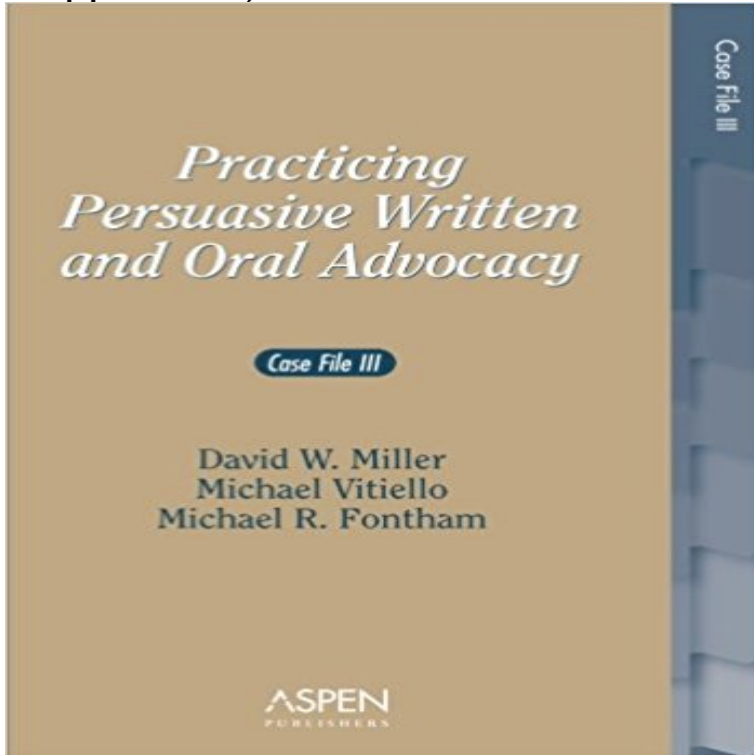


Practicing Persuasive Written and Oral Advocacy: Caes File III (Problem Supplement)
