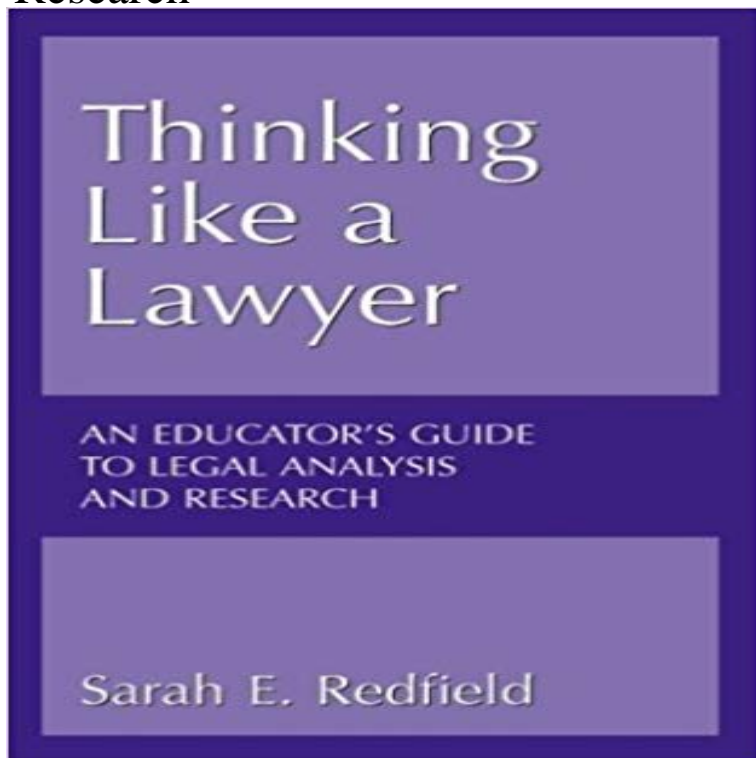


# Thinking Like a Lawyer: An Educators Guide to Legal Analysis and Research
