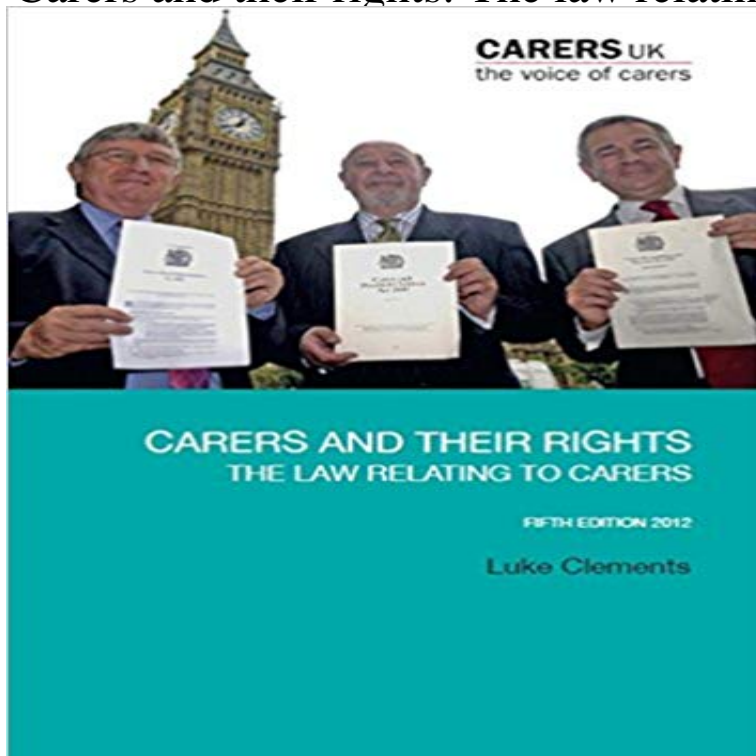


Carers and their rights: The law relating to carers
