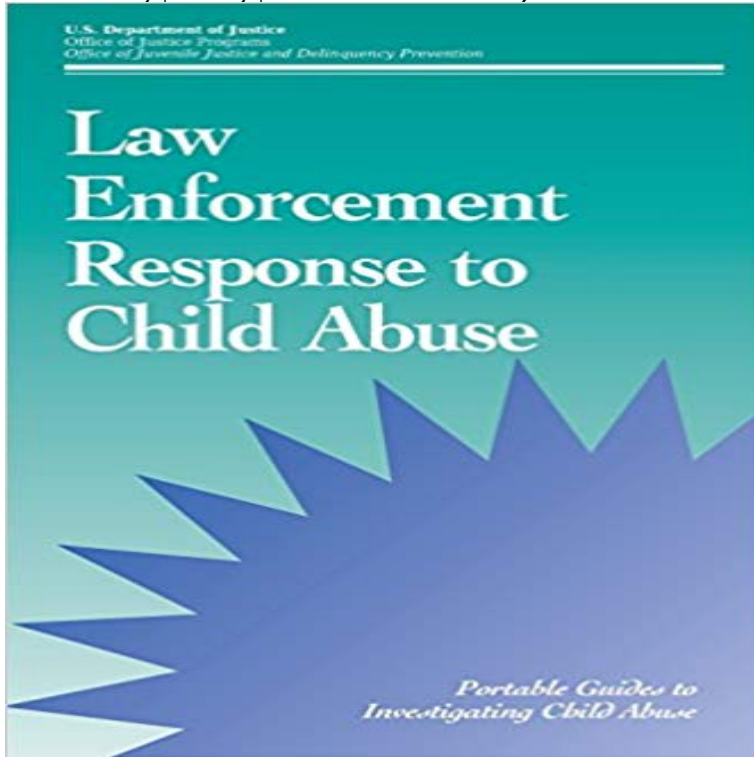


Law Enforcement Response to Child Abuse (Portable Guides to Investigating Child Abuse)
