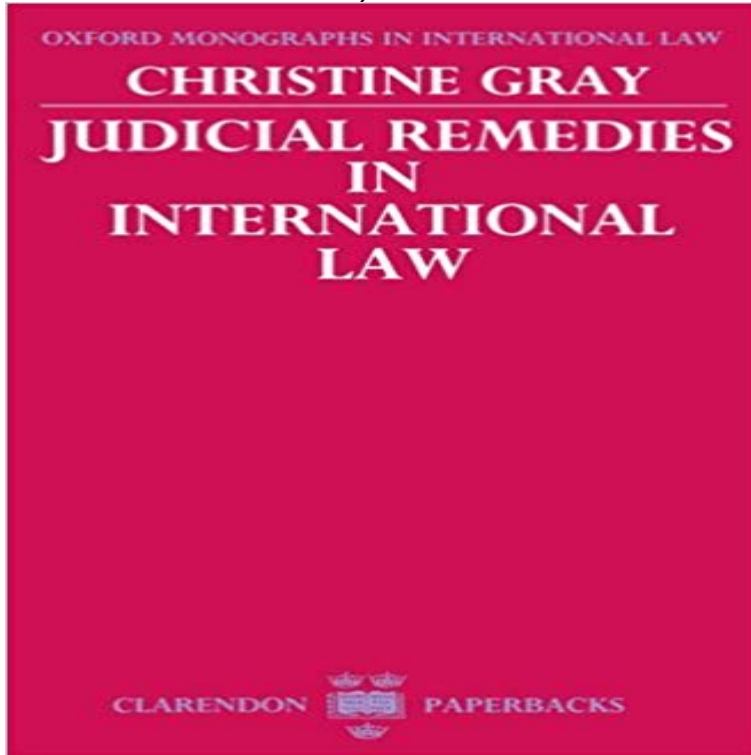


# Judicial Remedies in International Law (Oxford Monographs in International Law)
