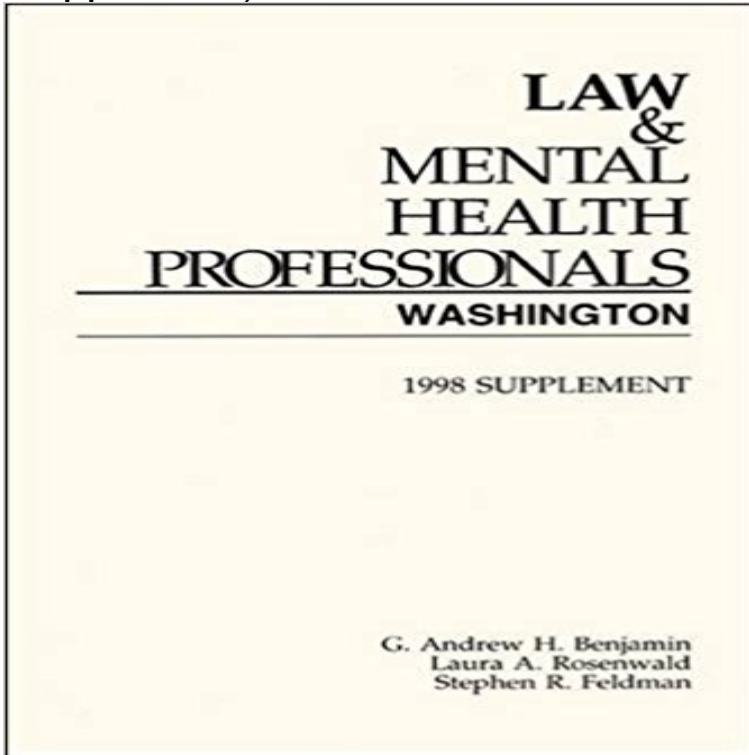


Law and Mental Health Professionals: Washington Supplement (1998 Supplement)
