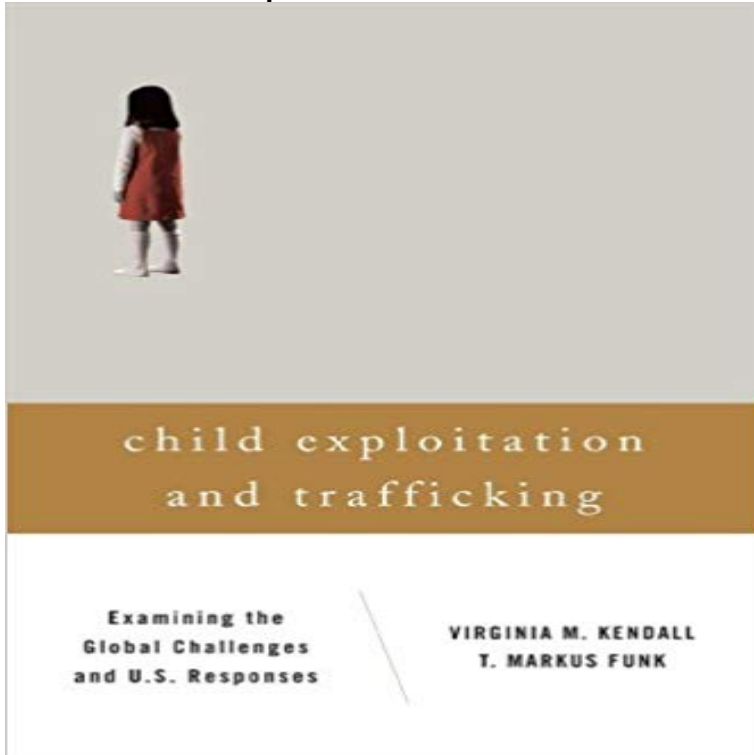


# Child Exploitation and Trafficking: Examining the Global Challenges and U.S. Responses
