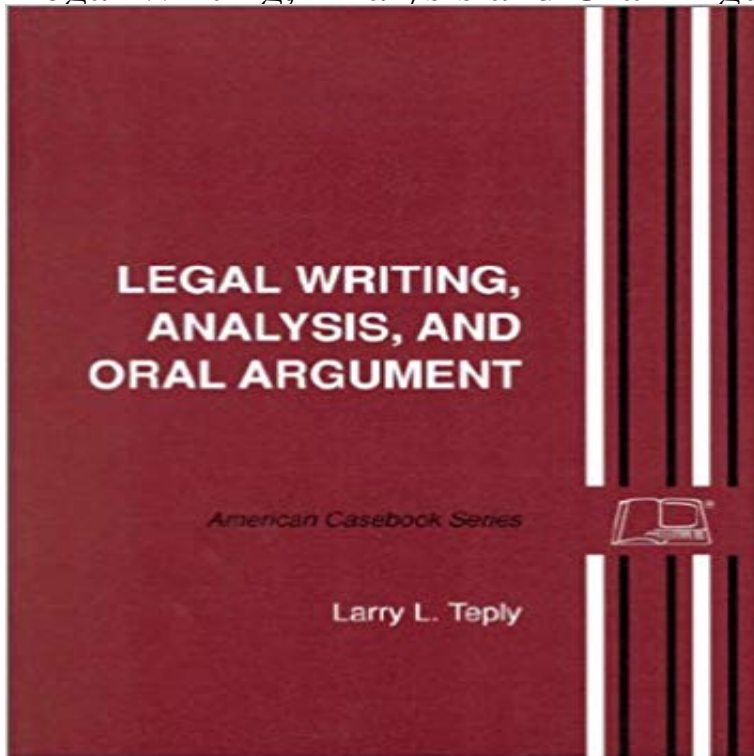


## Legal Writing, Analysis and Oral Argument (American Casebook Series)
