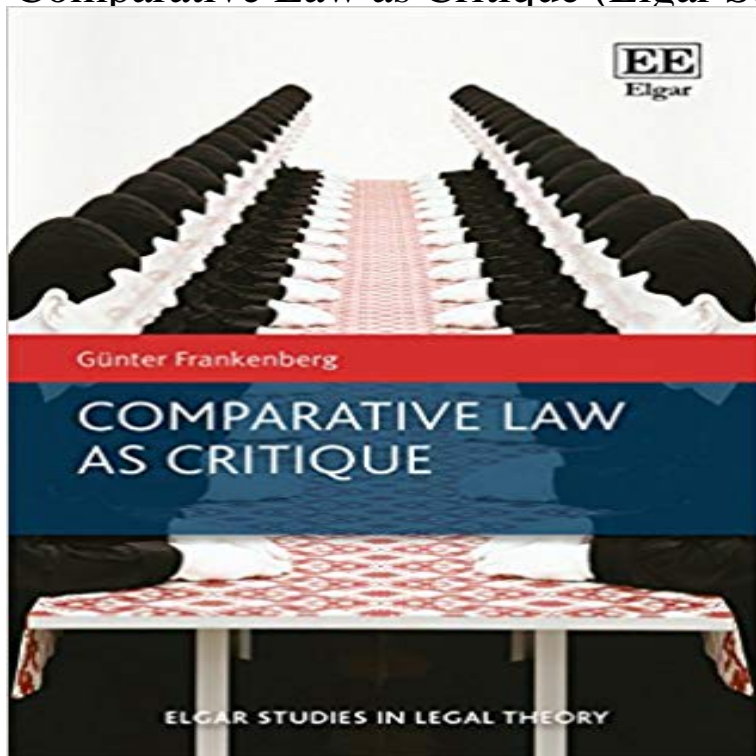


## Comparative Law as Critique (Elgar Studies in Legal Theory)
