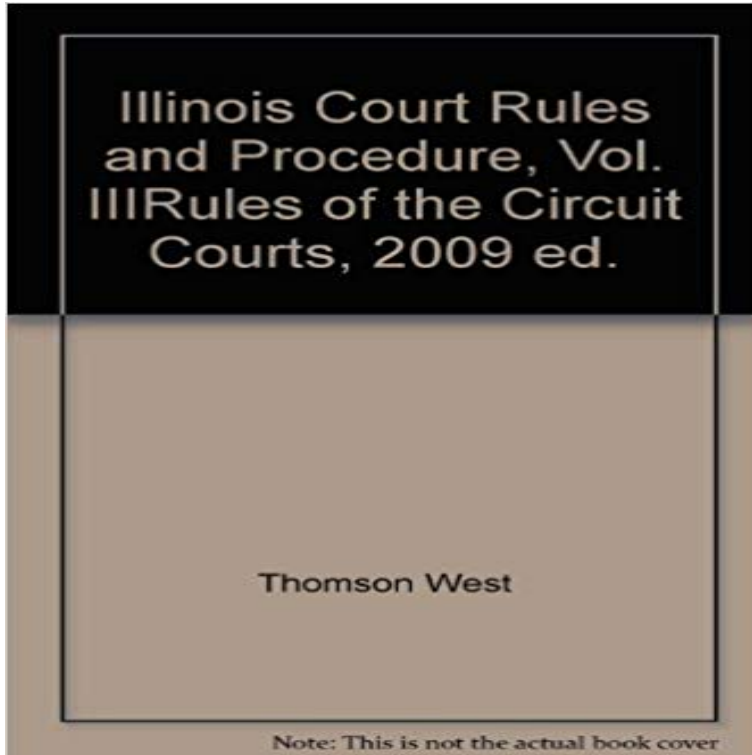


## Illinois Court Rules and Procedure, Vol. III Rules of the Circuit Courts, 2009 ed.
