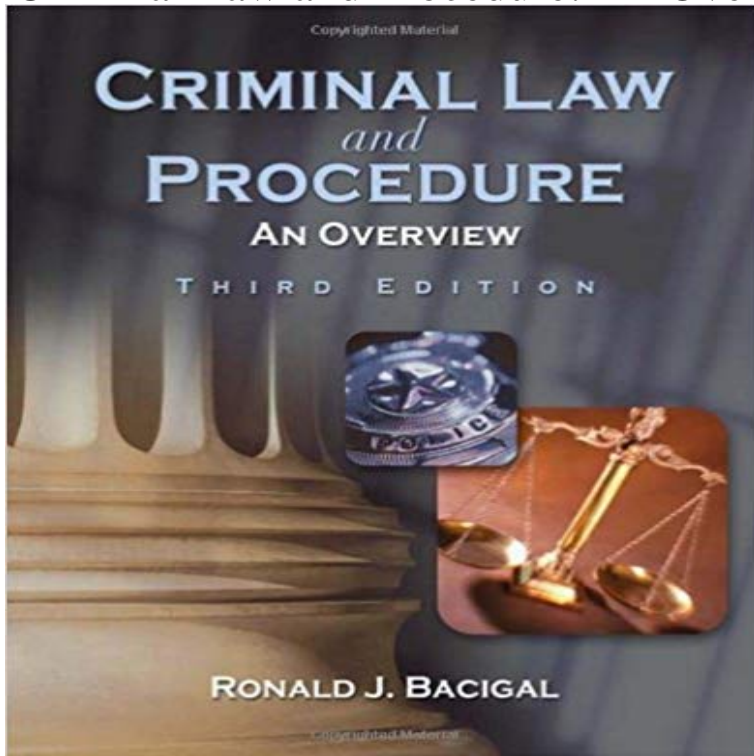


## Criminal Law and Procedure: An Overview

The first part defines criminal responsibility and addresses the major felonies recognized in most, if not all jurisdictions. The second half covers the procedural aspects of the entire criminal justice system from arrest to appeal and habeas corpus. Particular emphasis is placed on the fourth, fifth, and sixth amendments to the U.S. Constitution. The material provided in this resource constitutes a narrative account of the law. Abundant case summaries are interwoven to bring real world scenarios into the classroom. Chapter outlines open each chapter to focus attention on the main elements the student will encounter. Each chapter concludes with concept summary charts, discussion questions and practical exercises.
