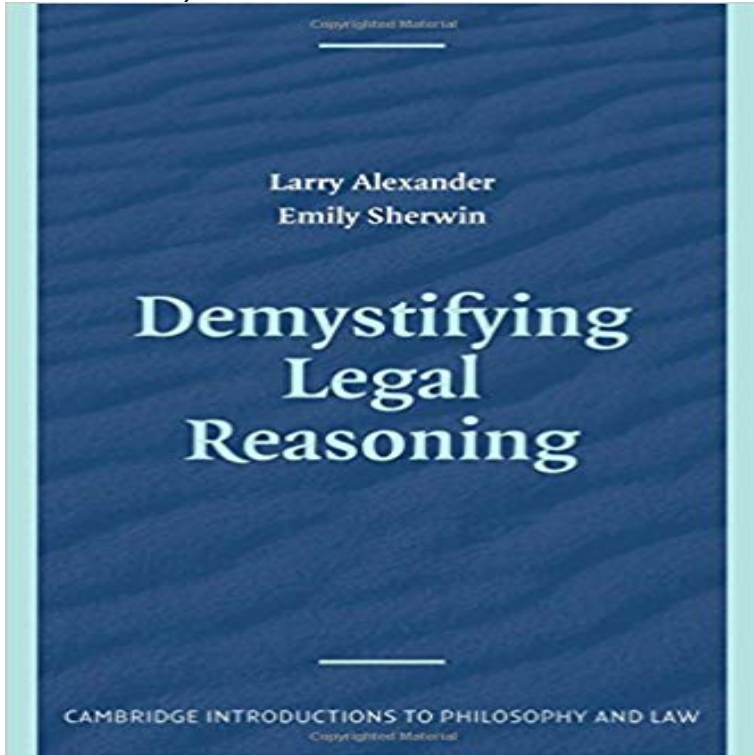


# Demystifying Legal Reasoning (Cambridge Introductions to Philosophy and Law)
