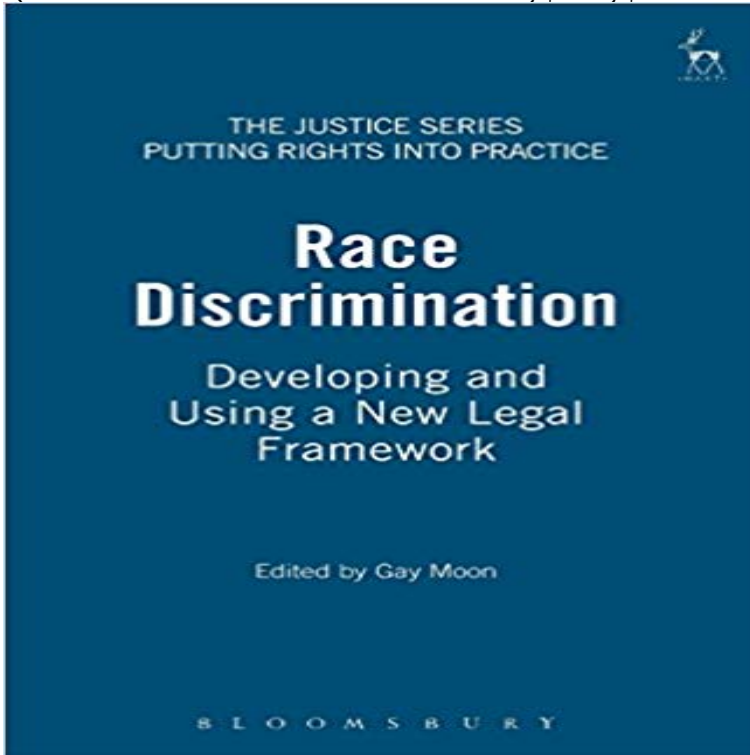


Race Discrimination: Developing and Using a New Legal Framework (The Justice Series - Putting Rights into Practice)
