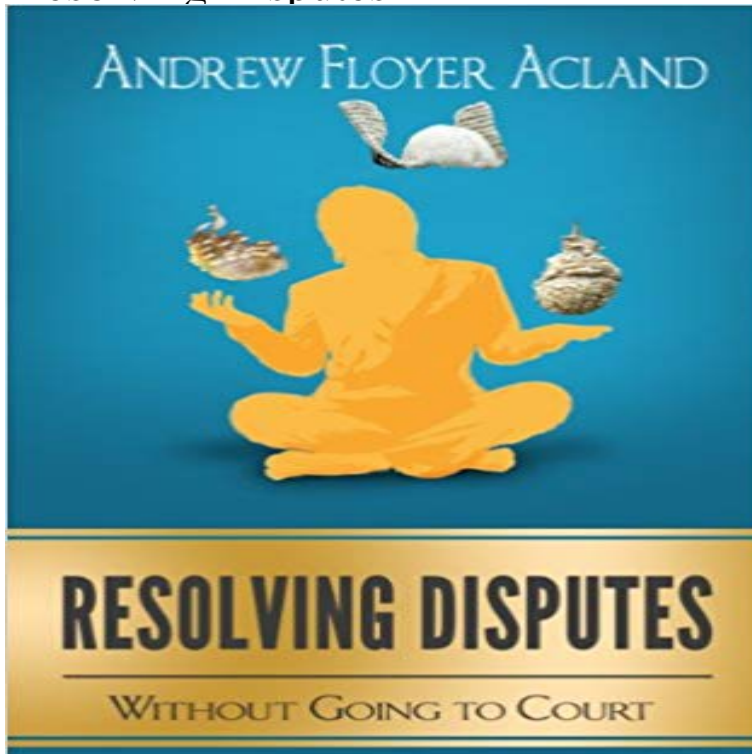


## Resolving Disputes



Resolving Disputes Without Going to Court: A Consumer Guide to Alternative Dispute Resolution was originally published in 1995 and was the successor to my first book, A Sudden Outbreak of Common Sense: Managing Conflict through Mediation, the first book in the United Kingdom to describe and promote the use of mediation to resolve legal and commercial disputes. In the near twenty years since Resolving Disputes the field of Alternative Dispute Resolution (ADR) has grown out of all recognition both here and around the world, and processes such as mediation are an increasingly formalised part of many legal systems. I have resisted the temptation to update it, however, because much of what it says remains as valid as it was when it was written. Readers and potential consumers of ADR services should though check providers current approaches and methods to ensure they are aware of what is on offer and how to take best advantage of it.
