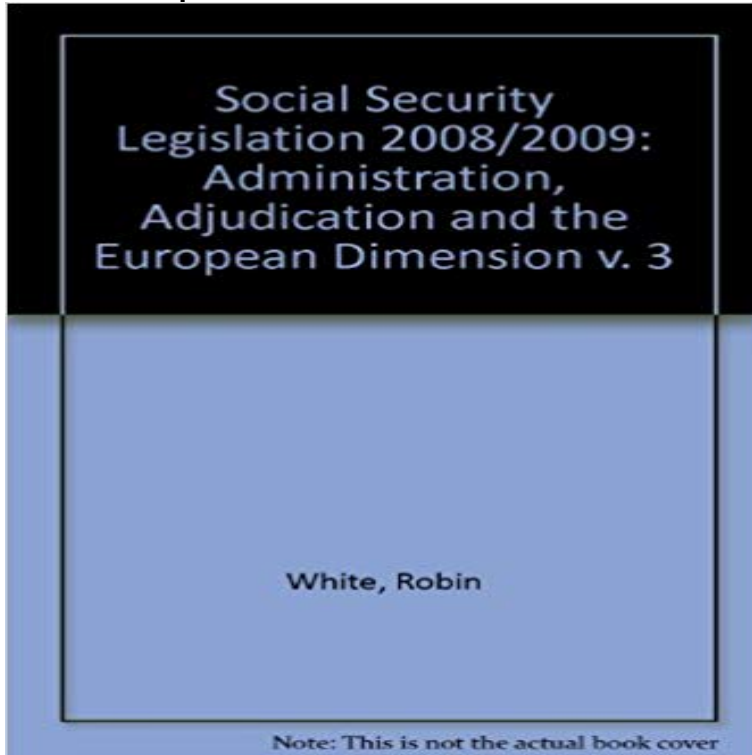


Social Security Legislation 2008/2009: Administration, Adjudication and the European Dimension v. 3
