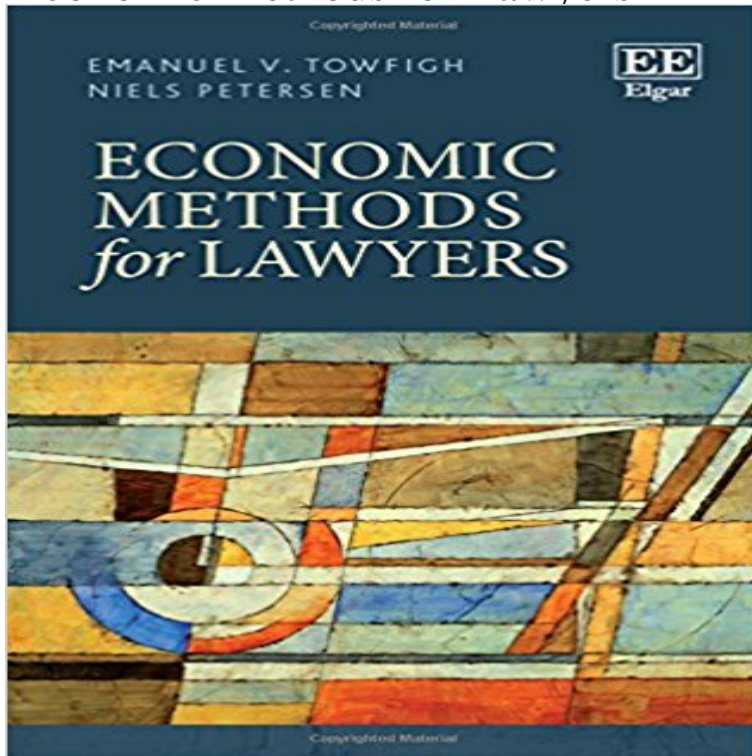


Economic Methods for Lawyers
