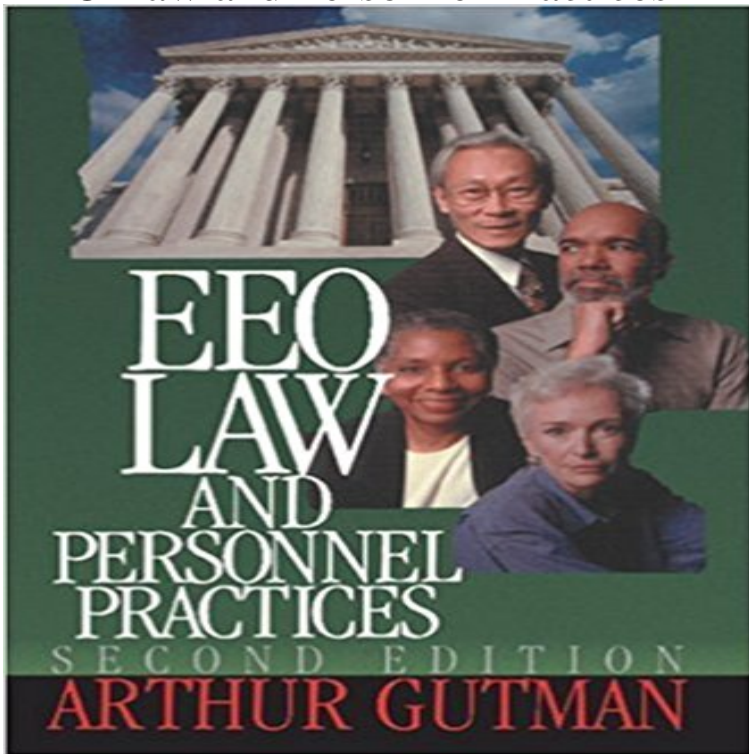


## EEO Law and Personnel Practices
