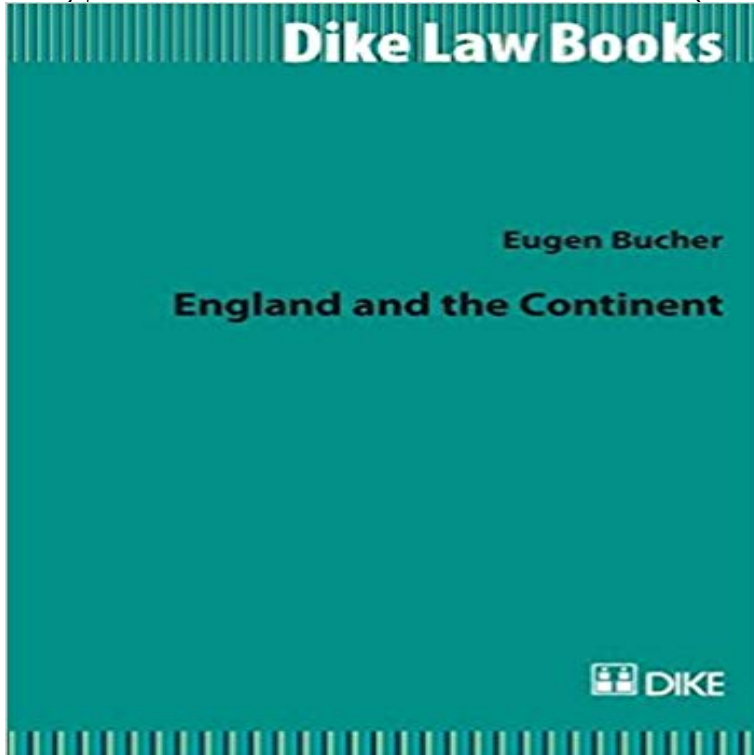


# England and the Continent: Distinguishing the Peculiarities of the English Common Law of Contract (Dike Law Books)
