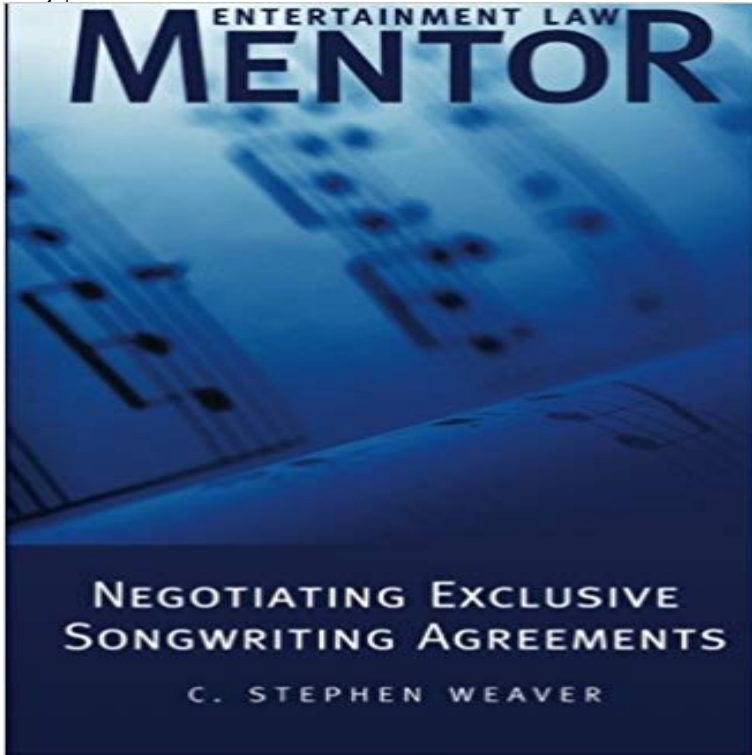


Entertainment Law Mentor - Negotiating Exclusive Songwriting Agreements
