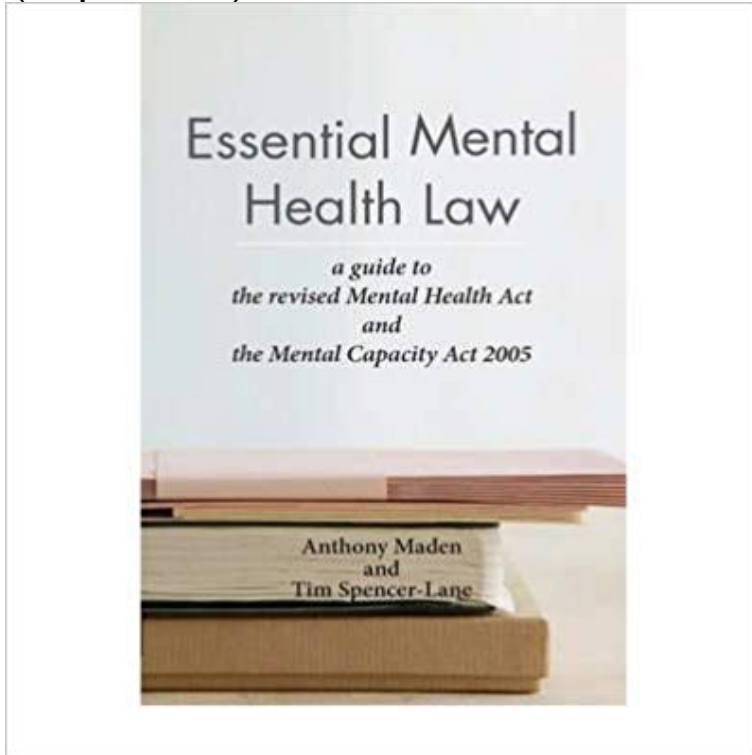


Essential Mental Health Law: A Guide to the New Mental Health Act (Paperback) - Common
