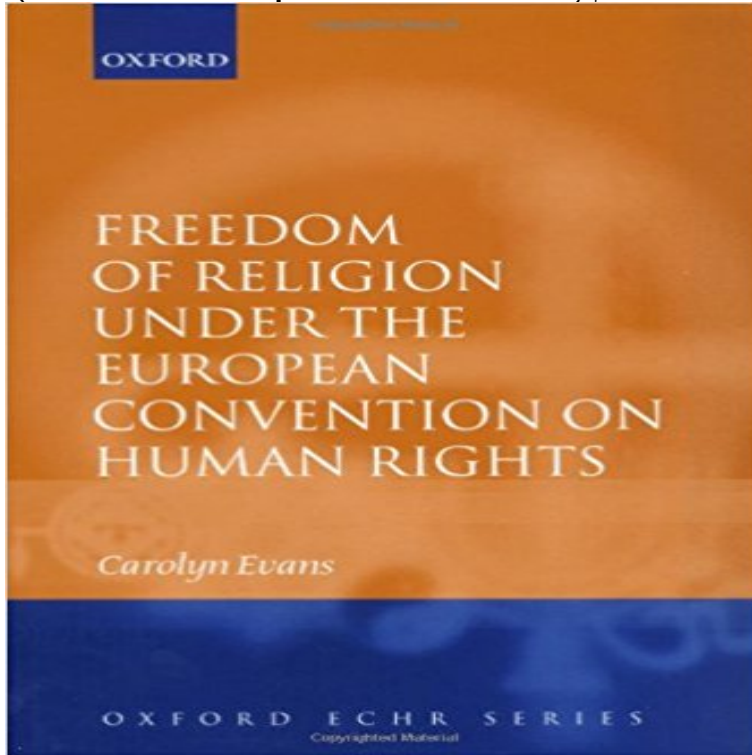


Freedom of Religion under the European Convention on Human Rights (Oxford European Human Rights Series)
