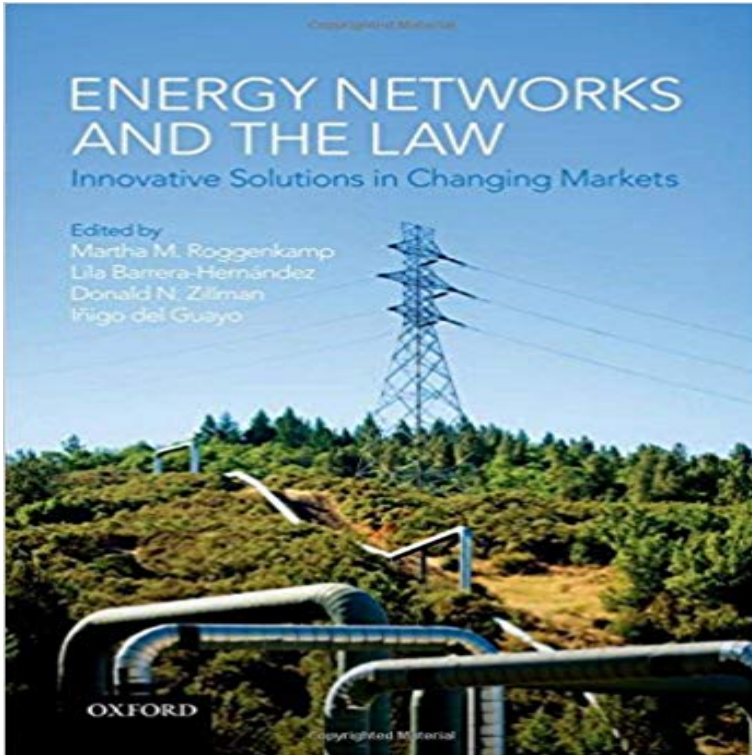


# Energy Networks and the Law: Innovative Solutions in Changing Markets
