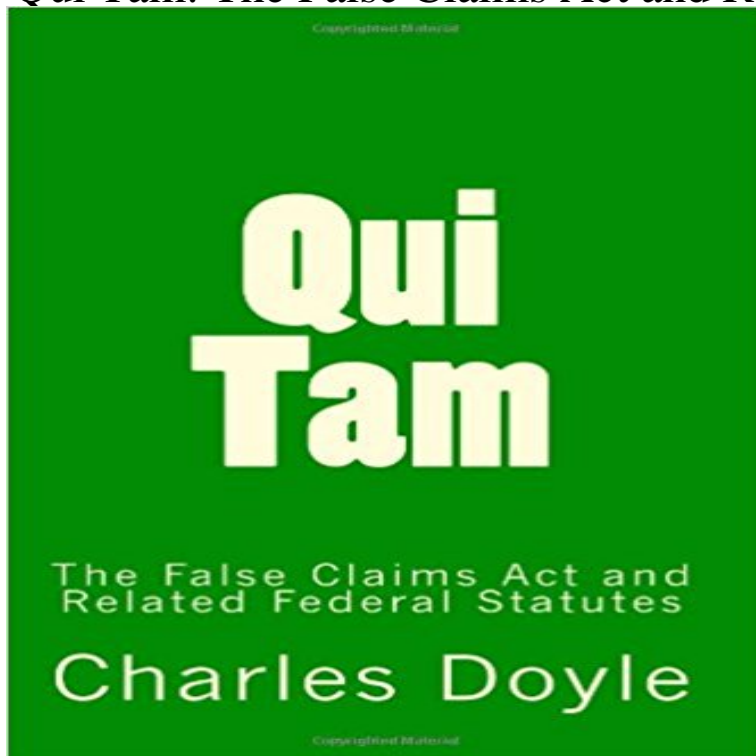


## Qui Tam: The False Claims Act and Related Federal Statutes
