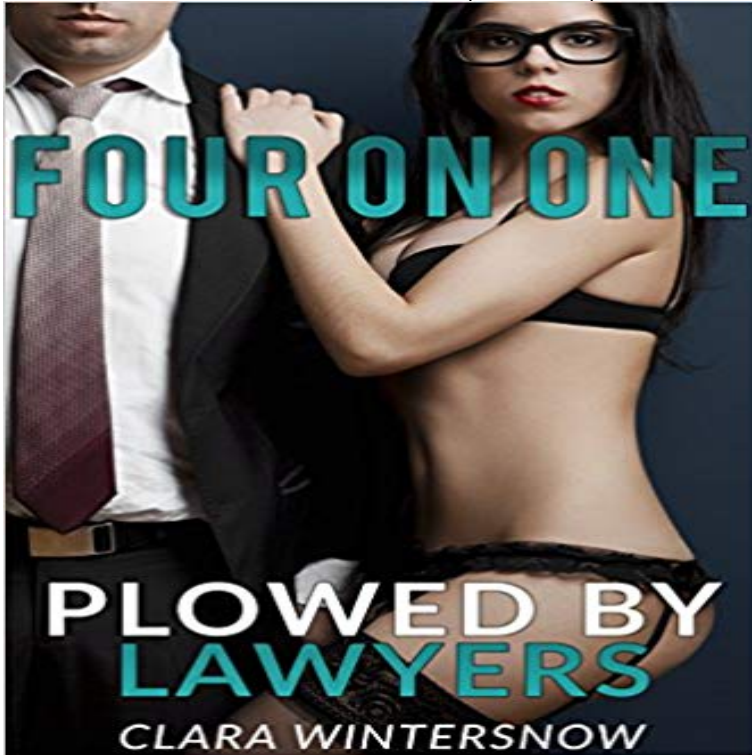


Four on One: Plowed by Lawyers
