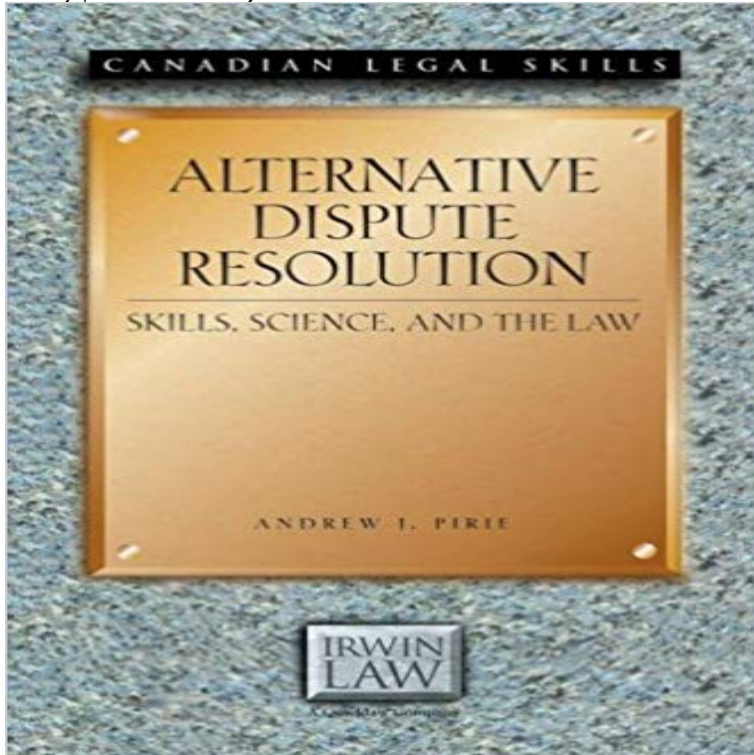


## Alternative Dispute Resolution: Skills, Science, and the Law (Canadian Legal Skills)
