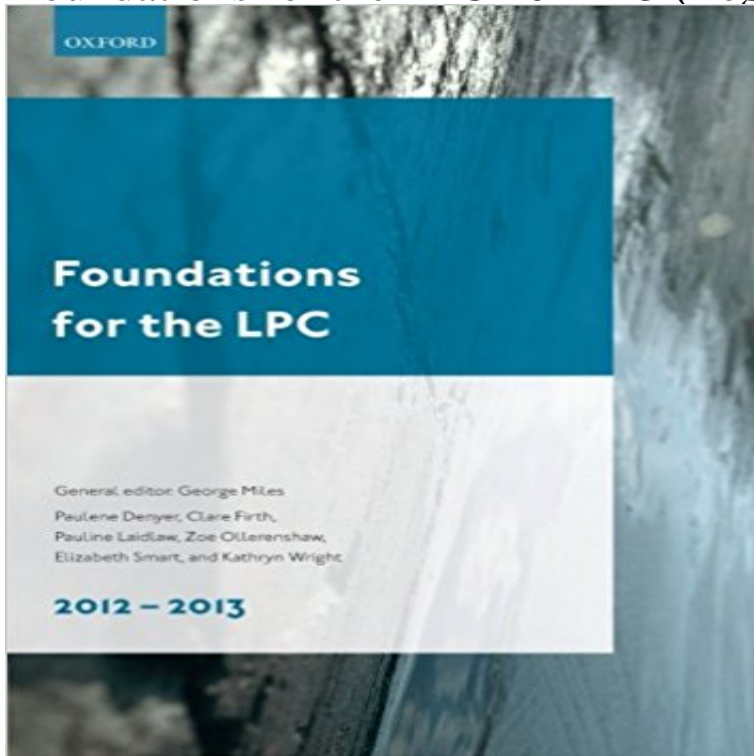


Foundations for the LPC 2012-13 (Legal Practice Course Guide)
