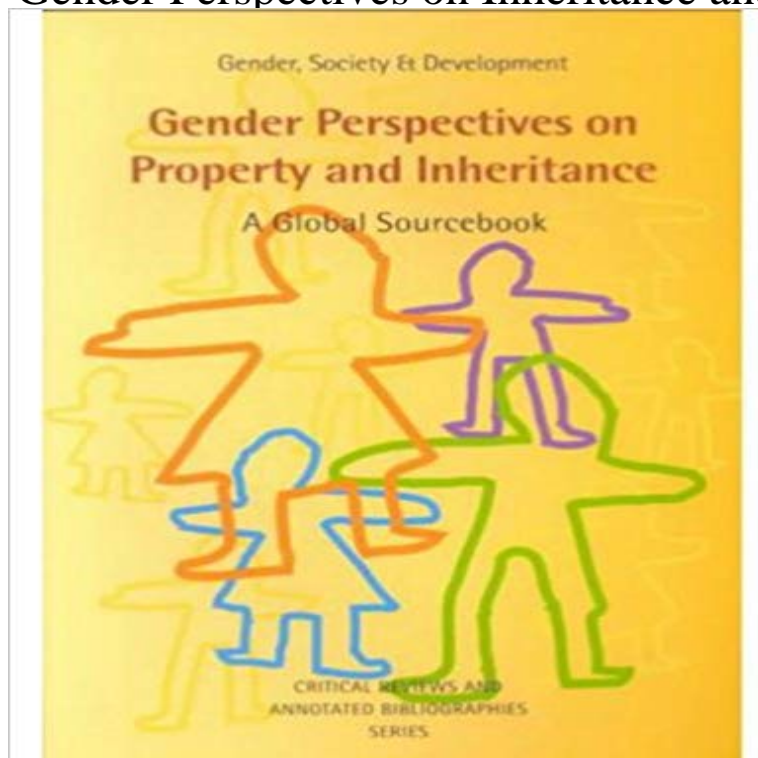


## Gender Perspectives on Inheritance and Property
