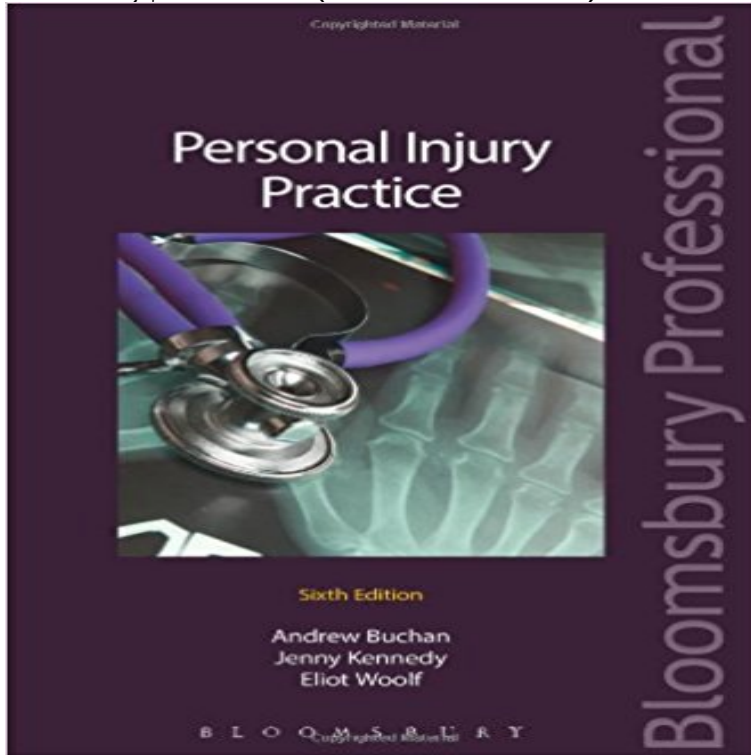


# Personal Injury Practice: The guide to litigation in the county court and the High Court (Sixth Edition)
