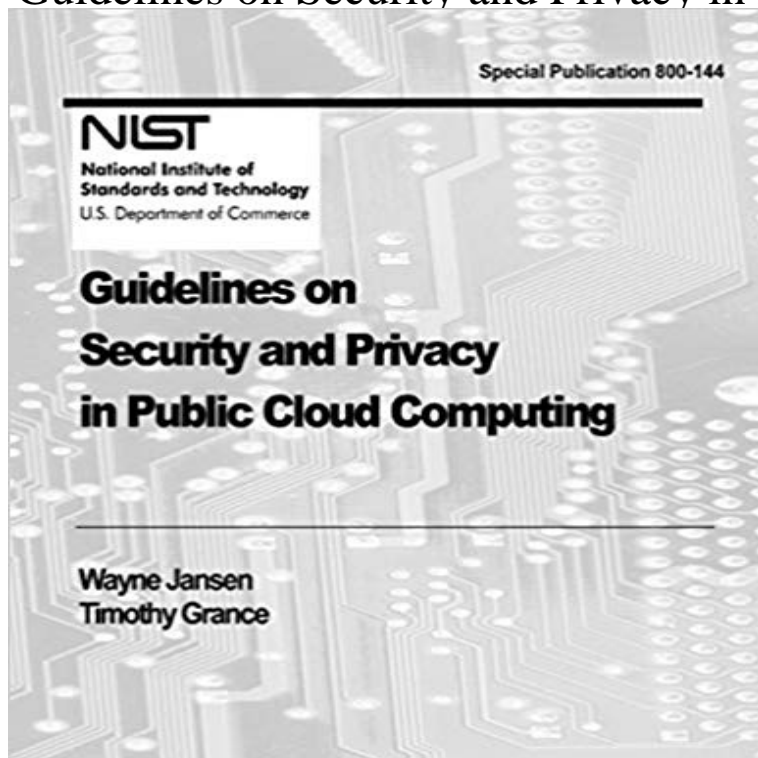


Guidelines on Security and Privacy in Public Cloud Computing
