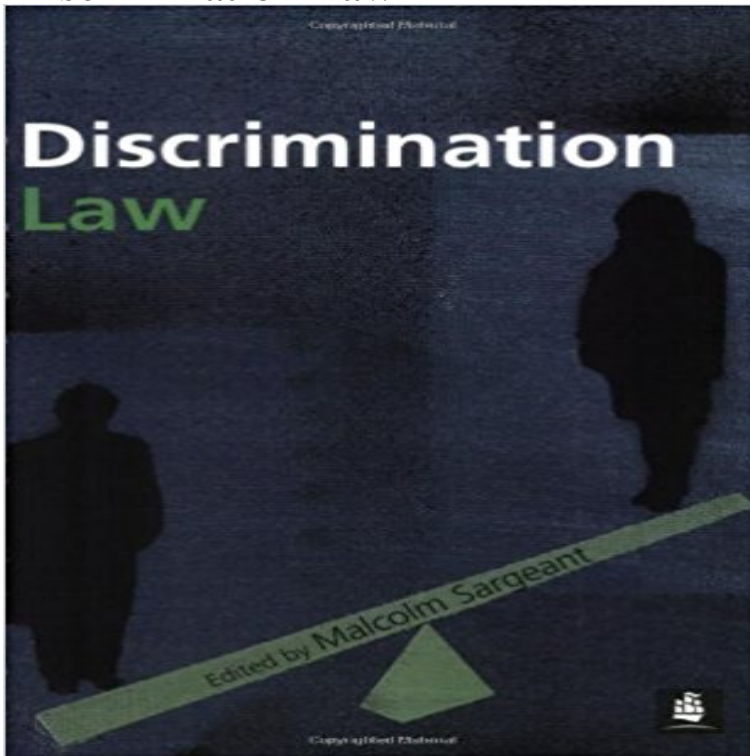


Discrimination Law
