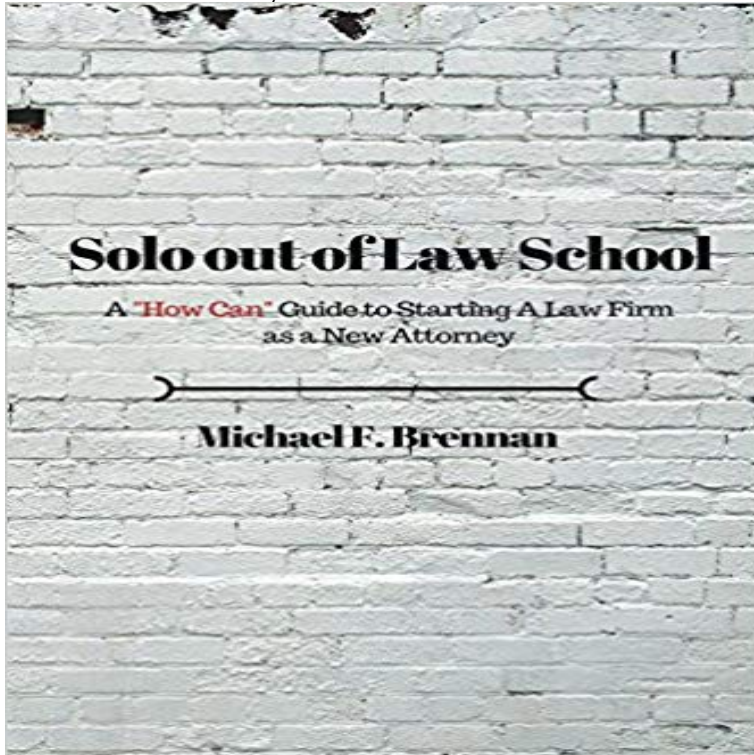


Solo Out of Law School: A How Can Guide to Starting a Law Firm as a New Attorney
