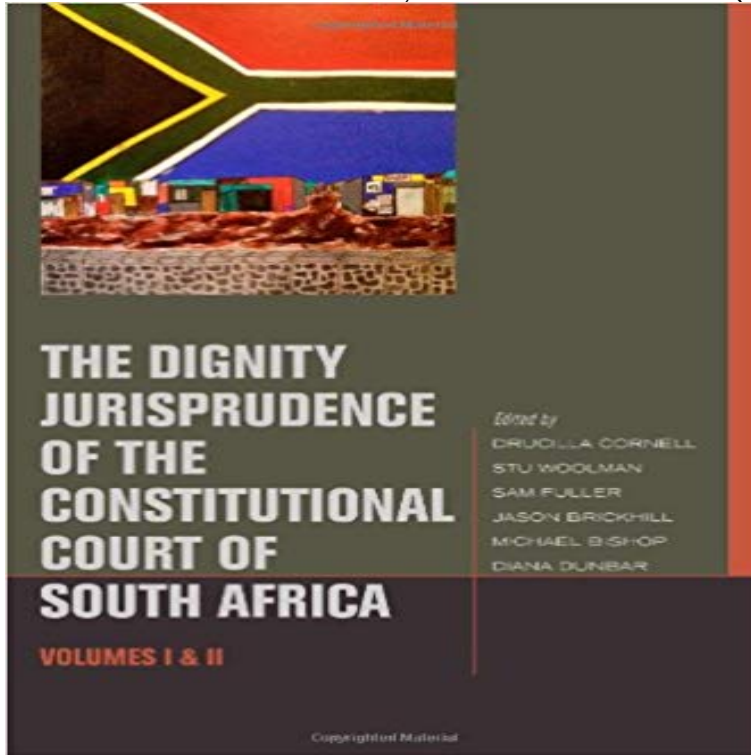


The Dignity Jurisprudence of the Constitutional Court of South Africa: Cases and Materials, Volumes I & II (Just Ideas (FUP))
