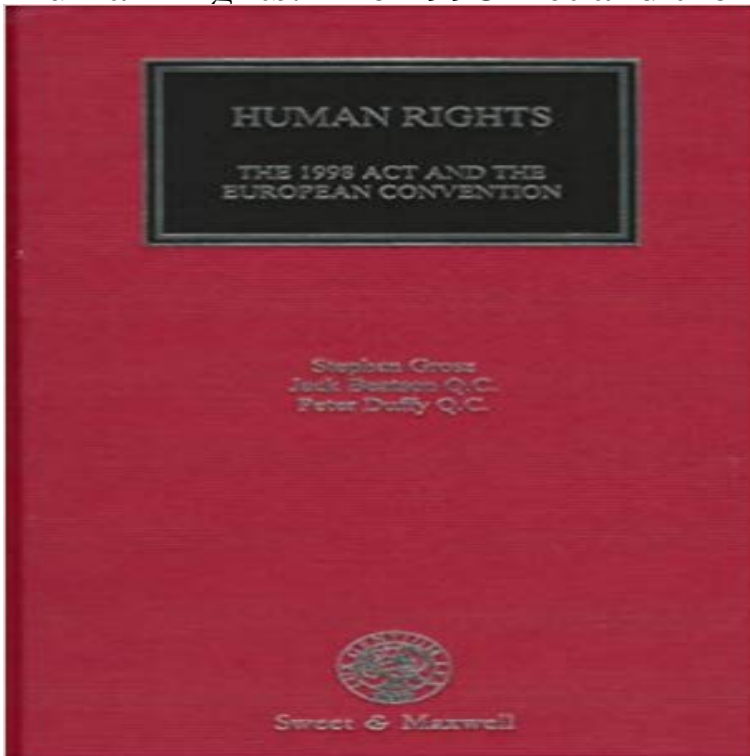


Human Rights: The 1998 Act and the European Convention
